SHOW REQUIREMENTS

- 1- All pigs must be sired by Purple Power Boar Stud, LLC through semen sales or through Bred gilt purchases to Purple Power Boars.
- 2- Pigs will show by Breed and Sex
- 3- All Purebred pigs must have Registration papers at the time of the sift. NO EXCEPTIONS!!!! Purple Power Boar Stud will transfer the papers to the new owners 30 days after the sale.
- 4- The Entry is 15.00 for Barrows and Gilt. 25.00 For Boars and must be postmarked by Thursday March 11, 2010. FEES MUST ACCOMPANY. All Late entries will be doubled. All entries are non-refundable. A commission fee of 12% will be charged on all pigs sold. Proceeds from the sale will be paid within 30 days from March 28, 2010. In case of insufficient funds and or nonpayment by the buyer, settlement will be delayed until the collection is secured.
- 5- Health requirements-An Interstate health certificate of veterinarian must accompany each animal .THE ORIGINAL HEALTH CERTIFICATE MUST ACCOMPANY SHIPMENT AND ONE PHOTOCOPIES OF THE ORIGINAL CERTIFICATE MUST BE SUPPLIED FOR EACH ANIMAL. Each certificate must show the name address of the consignor and be consigned to the Purple Power Boar Stud, LLC Customer Appreciation Sale and the individual identification of each animal is required, ear notch are acceptable for purebred animals but federal ear tags are required for all crossbred animals.
